FOREWORD

I. PABSEC SUMMIT

The Summit of the Presidents of the Parliaments of the PABSEC Member-Countries was held in Chisinau, on 10 June 2003, within the framework of the 21st General Assembly upon the decision of the 27th Meeting of the Bureau of the Assembly taking up the subject: *The Ten Years' Experience of PABSEC: Achievements and Prospects*.

Mrs. Eugenia Ostapciuc, President of the Parliament of the Republic of Moldova, Mr. Nicolae Vacaroiu, President of the Senate of Romania, Mr. Sergey Mironov, Chairman of the Council of Federation of the Russian Federation, Mrs. Makbule Ceco, Deputy Speaker of the Parliament of the Republic of Albania, Mr. Arif Ragim-Zade, Deputy Chairman of the National Assembly of the Republic of Azerbaijan, Mr. Blagovest Sendov, Vice-President of the National Assembly of the Republic of Bulgaria, Mr. Panayotis Sgouridis, Vice-President of the Parliament of the Hellenic Republic, Mr. Gennady Vasiliev, First Deputy Chairman of the Verkhovna Rada of Ukraine and special representatives - Mr. Malkhaz Baramidze (Parliament of Georgia) and Mr. Salih Kapusuz (Grand National Assembly of the Turkish Republic) delivered statements and signed *the Declaration on the Tenth Anniversary of the Parliamentary Assembly of the Organisation of the Black Sea Economic Cooperation*.

II. PLENARY SESSION

OPENING CEREMONY

The Twenty First General Assembly of the Parliamentary Assembly of the Organisation of the Black Sea Economic Cooperation was held in Chisinau on 10-12 June 2003 upon the invitation of the Parliament of the Republic of Moldova.

The Plenary Session was opened by Mrs. Eugenia OSTAPCIUC, President of the Parliamentary Assembly of the Organisation of the Black Sea Economic Cooperation, President of the Parliament of the Republic of Moldova. H.E. Mr. Vladimir Voronin, President of the Republic of Moldova, addressed the General Assembly. The message addressed to the General Assembly by Mr. Vilayet GULIYEV, Chairman-in-Office of the Organisation of the Black Sea Economic Cooperation, Minister of Foreign Affairs of the Republic of Azerbaijan, was presented by Mr. Taliat ALIYEV, Ambassador of the Republic of Azerbaijan to the Republic of Moldova.

GENERAL DEBATE

The General Debate was devoted to "The Role of Parliaments in the Economic Development and the Consolidation of Stability in the PABSEC Member - Countries".

The Heads of National Delegations, representatives of the observers from German Bundestag, the Knesset of State of Israel, the European Parliament, Parliamentary Assembly of the Council of Europe and Parliamentary Assembly of the Belarus-Russia Union took part in the General Debate.

The speakers underlined that during the decade of the PABSEC activities, the Member States have undertaken major steps in direction of economic development and strengthening of stability. Now they joined their efforts for the implementation of the the BSEC Economic Agenda for the Future.

They stressed the role of parliaments in the adoption of appropriate legislation, securing development of economy and possibilities for economic cooperation among the countries of the region, as well as the necessity of harmonisation of legislation with the EU in connection with entering of some PABSEC Member Countries into that organisation and speeding up integration with Europe. It was mentioned that the Parliamentary Assembly assists the parliaments of the Member States in elaboration and adoption of harmonised legislation. The PABSEC recommendations are directed first of all at deepening of economic cooperation, strengthening stability and achieving higher degree of integration.

The members of Parliamentary Assembly called to join efforts for consolidation of stability and resolution of conflicts in the PABSEC Member States, which will positively influence the economic development of the countries and of the region as a whole.

ORGANISATION OF THE BLACK SEA ECONOMIC COOPERATION:

The Assembly reviewed the main activities carried out by the BSEC during the last six months and underlined the importance of the Eighth Meeting of the Council of Ministers of Foreign Affairs of the BSEC Member-States held on 18 April 2003 in Yerevan.

The Assembly appreciated the informations provided by the Secretary General, Mr. Valery Chechelashvili on the activities of the Organisation of the BSEC and by Mr. Yannis Papanicolau, Director General of the International Centre for Black Sea Studies. The message by Mr. Mustafa Gurtin, President of the Black Sea Trade and Development Bank was delivered by Mr. Valery Aksenov, External Relations Manager of the BSTDB.

The members of the national delegations took part in the debate, underlining the importance of the BSEC activities in order to speed up economic cooperation process in the Black Sea Region.
