## FOREWORD

### OPENING CEREMONY

The Twenty Ninth General Assembly of the Parliamentary Assembly of the Organization of the Black Sea Economic Cooperation was held in Varna on 12-14 June 2007 upon the invitation of the National Assembly of the Republic of Bulgaria.

The Plenary Session was opened by Mr. Georgi Pirinski, President of the Parliamentary Assembly of the Organization of the Black Sea Economic Cooperation, Chairman of the National Assembly of the Republic of Bulgaria. The message of H.E. Mr. Georgi Pirvanov, President of the Republic of Bulgaria, was delivered to the participants of the Plenary Session by his representative Mr. Boyko Radoev. Mr. Ahmet Ulker, Consul General of the Republic of Turkey in Burgas, on behalf of the Turkish BSEC Chairman-in-Office presented the message addressed to the General Assembly by H.E. Mr. Abdullah Gül, Deputy Prime Minister, Minister of Foreign Affairs of the Republic of Turkey.

## **THE PLENARY SESSION**

### **1. *General debate.***

The topic of the General Debate was “The Organisation of the Black Sea Economic Cooperation and the European Union: New Euro-Black Sea partnership”.

The heads and members of the National PABSEC Delegations, Senate of the French Republic, representatives of the EP, the IPA EurAsEC, the European Commission, the IPAO and the PUIC took part in the General Debate.

The speakers in the debate welcomed the concrete actions undertaken by the BSEC in the recent period with a view to strengthening relations with the EU, as well as the efforts of the PABSEC to continue the development of relations with the European Parliament. The visit of the PABSEC delegation to the European Parliament in February 2007 represented an excellent opportunity to exchange views on issues of common interest for both the PABSEC and the EP.

The need was emphasized for establishing a new partnership between the Black Sea region and the EU, due to the strategic importance of our region, especially as a transit route for energy resources. The participants stressed that the Black Sea region could bring a great contribution to ensuring the energy security for the European continent. It was also mentioned that although there is a huge potential for developing a closer relation with the EU, a grave obstacle in advancing on the path of collaboration is represented by the frozen conflicts, which are also a threat to the stability and security of the Black Sea region.

The speakers greatly welcomed the elaboration of the Communication of the European Commission on strengthening the European Neighborhood Policy, as well as the “Black Sea Synergy - a new Regional Cooperation Initiative”, addressed to the Council and the European Parliament, as a new initiative meant to develop the deepen cooperation within the Black Sea region and the EU. At the same time, the participants welcomed the application of the European Commission for the Observer Status to the BSEC.

A hope was expressed that the future report of the European Parliament on the Black Sea Synergy will definitely be an important step towards developing a new approach to the Euro - Black Sea relations. It was stressed that the relations between the BSEC and the EU are considered a key instrument for promoting multifaceted regional cooperation in the Black Sea, while the relations established between our parliamentary bodies could serve as an example of useful contacts and enriching experience of working together.

The participants emphasized that the Black Sea countries must continue to work together and give a new impetus to the cooperation for sustaining regional stability and prosperity, and that the closer interaction with the European structures will consolidate trust, partnership and understanding. The members of PABSEC agreed on the importance of being more involved in the development of relations of cooperation with the European Parliament.

The speakers also extended their congratulations to the BSEC on its 15<sup>TH</sup> Anniversary, which represents an important landmark in the development of the wider Black Sea Region, meant to consolidate the relations among our countries and promote progress, security and prosperity for our people.
